Proposal under Article 18 of the Law on Normative Acts: three draft laws amending and supplementing the Criminal Code, the Criminal Procedure Code, and the Judicial System Act, with explanatory memoranda

Message

Dear Sir or Madam:

Pursuant to Article 45 of the Constitution of the Republic of Bulgaria and Article 18(1) and (2) of the Law on Normative Acts, I submit in my own name, in my capacity as an attorney, author, and submitting party, three draft laws amending and supplementing the Criminal Code, the Criminal Procedure Code, and the Judicial System Act, accompanied by explanatory memoranda.

The proposals seek to improve protection under criminal law, strengthen procedural safeguards and judicial review, limit opportunities for abuse of powers, and increase transparency and accountability in the governance of the judiciary.

The package is addressed to the Ministry of Justice, the Council of Ministers, and the National Assembly. The requests to each recipient reflect its respective competence:

1. To the Ministry of Justice: to conduct an expert assessment of the proposals and consider taking the necessary steps to prepare draft laws, including impact assessment, interinstitutional coordination, and public consultation, with a view to their possible submission to the Council of Ministers.
2. To the Council of Ministers: to consider the proposals in light of its power under Article 87(1) of the Constitution and, if it reaches a favorable assessment, to commission the preparatory work necessary to exercise legislative initiative.
3. To the National Assembly, through its President: to refer the proposal to the Legal Affairs Committee and make it available to the Members of Parliament for their consideration, discussion under the established procedure, and assessment of whether to exercise legislative initiative.
